Contributions to Beth for Indiana are not tax deductible as charitable donations for federal income tax purposes. Federal law requires political committees to use their best efforts to obtain and report the name, mailing address, occupation and employer of each contributor. Under federal law, individuals may contribute a maximum of \$2,800 per election cycle. Couples may contribute \$5,600 per election cycle and may make contributions from a joint account, but in those cases, each contributor must sign the check or a statement that accompanies the contribution describing the joint attribution. Qualified federal PACs may contribute a maximum of \$5,000 per election. Federal law requires the reporting of the name, address, occupation, and employers of those individuals whose contributions aggregate in excess of \$200 in an election cycle. Contributions from corporations, foreign nationals and federal government contractors are prohibited. Not printed at government expense.
